Voc. (Food Technology, Nutrition and Management) programme of UGC Guideline under National Skill Qualifications Framework (NSQF) at Mugberia Gangadhar Mahavidyalaya at Bhupatinagar, Purba Medinipur. The Industry Partner shall avail of the Class rooms, Computer Laboratories, Practical Laboratories and other facilities of the College for conducting the above and programme is herewith signed and sealed.

The terms and conditions for the same as agreed upon is as follows.

1. The College shall take the responsibility for conducting the courses at their campus. The College shall provide the entire necessary infrastructure viz; Class rooms, Computer Laboratories with UPS, High Speed Internet connection and necessary furniture, Proper seating arrangements, Electricity along with generator facility and other students' amenities as required for the smooth conducting of the classes. The computers to be provided in 1:2 ratio. The faculty/ instructors as required for conducting the M. Voc. (Food Technology, Nutrition and Management) shall be provided by Industry Partner.

The College and Industry Partner shall be responsible for conducting the programmes till the end of the programmes in scheduled time in a proper manner and in no manner left incomplete or harm the interest of the students. Once a batch commences all the classes till the end shall continue at the College campus.
3. Industry Partner/Academic Partner will provide the curriculum design, content as per the industry requirement / shall gap and focus on work readiness
4. The College shall pay all the necessary payments to the Industry Partner/Academic Partner for its service rendered for conducting of the courses as per the norms laid down by the UGC for the programme.
5. The agreement shall commence with retrospective effect from 1st July, 2020. *valid upto 30th June, 2025*
6. The Memorandum of Agreement (MOU) shall be executed in duplicate, The College shall retain the original and Industry Partner the duplicate.

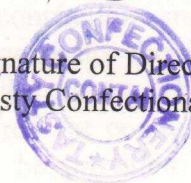

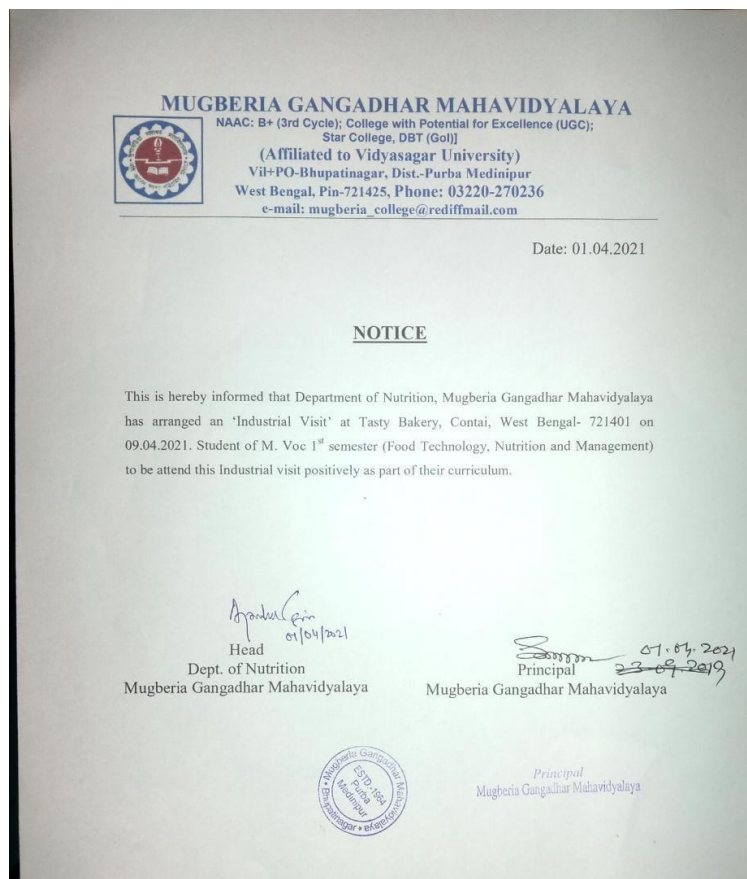
