**PROVISIONAL SELECTION LETTER**



Miss Anuradha Sau should clearly understand that her selection as GDSBPM is  
subject to verification of original certificates such as educational certificate, certificate  
of date of birth, caste certificate, disability certificate, computer certificate (60days)  
from the respective issuing authorities and subject to fulfilment for the following  
terms and conditions before the engagement with Department of Posts as per rule 3A  
of GDS Conduct & engagement Rules 2011. **It is also mentioned that his/her  
selection is subject to the outcome of WPCT No-6356(W)/2018 pending at  
Hon'ble High Court, Calcutta.**

- a. Undertaking of having alternative source of income besides the allowance to  
maintain adequate means of livelihood. (Rule 3-A (ii) of GDS Conduct and  
Engagement Rules, 2011) However, this shall not be a pre-requisition for  
candidates for the purpose of engagement as GDS
- b. Taking up accommodation in the post village (for GDS BPM) / ~~provisional  
provision of other employees of GDS~~ of the Post Office. (Rule 3-A (vii) of GDS  
Conduct and Engagement Rules, 2011)
- c. BPM has to provide standard accommodation for the Branch Post Office in the  
post village where he has been selected. (Rule 3-A (viii) of GDS Conduct and  
Engagement Rules, 2011) (Clarification of standard accommodation - Min 100  
sq ft, Front Space, Accessibility, Electricity etc)
- d. The GDS has to furnish security amount of Rs 1,00,000/- in the form of fidelity  
guarantee bond/ National Savings Certificate pledged to the Department in the  
name of President of India/ in the shape of bank guarantee in any Nationalized  
Bank. (Dte Letter no. 17-18/2018-GDS dtd 14 01 2020)

If no response is received from you within 30 days from the day of receipt of this letter,  
the Provisional selection will liable to be cancelled and you shall have no claim for
